Vide reference cited application are invited from the general public who are qualified for the post of APSRTC Constable.

Applications are now invited On-line through <http://apsrtc.cgg.gov.in> from eligible Departmental candidates also for Recruitment to the post of APSRTC Constables. The qualifications and other eligibility criteria prescribed are as follows.

The departmental candidates have to apply ON-LINE only and application in any other form will not be entertained.

- 1.Reservation for BC-E group will be subject to adjudication of the litigation pending before the Hon'ble courts and Government orders from time to time.
 - 2.Number of posts mentioned above are provisional. They may vary upwards or downwards.
 - 3.Candidates who acquired qualification up to last date of submission of applications need only to apply.
 4. PHC candidates are not eligible for the post.

For Departmental (APSRTC in-service) candidates appointed on regular basis age will be reckoned as follows:

- By 5 years in upper age limit in respect of SC/ST/BC candidates.
- In addition to the above, employees belonging to SC/ST/BC categories are given age relaxation to the extent of entire service rendered in the Corporation on regular basis, for the purpose of maximum age limit prescribed for the post, subject to the condition that the present age of the employee should not exceed **45** years. That is to say that the regular service rendered in the Corporation as on **25.01.2012** (last date for submission of application) should be deducted from the age of the candidates as on **1.7.2011**. After this deduction, if the age of the candidate falls within **27** years (male employee) and **30** years (for female employee) the candidate is eligible. If it exceeds Male-**27** years, Female-**30** years, the candidates becomes over aged and gets rejected automatically.
- Employees other than those of SC/ST/BC categories are given age relaxation upto a maximum of **10** years regular service rendered in the Corporation for the purpose of maximum age limit prescribed for the post. That is to say that the regular service rendered in the Corporation as on **25.01.2012** (Last date for submission of application) up to a maximum of **10** years should be deducted from the age of the candidate as on **1.7.2011**. After this deduction, if the age of the candidate falls within **27** years for male candidates and **30** years for female candidates are eligible. If it exceeds **27** (Male), **30** (Female) years, the candidates becomes overaged and gets rejected automatically.

4. HOW TO APPLY:

Detailed notification with break-up of vacancies, Scale of pay, Age, Community, Educational Qualifications and other instructions along with syllabus for the written examination may be viewed at APSRTC Website <http://apsrtc.cgg.gov.in> from **05.01.2012**.

- a. The applicants are required to go through the detailed notification and decide themselves as to their eligibility for this recruitment carefully before applying and enter the particulars completely online.
- b. Fee: Each applicant must pay Rs.200/- (Rupees two hundred only) towards Application Fee. They need not pay any Examination fee.
- c. **MODE OF PAYMENT OF FEE:** The Applicant should pay the prescribed fee as per the notification in any one of the A.P. Online centers and obtain Fee paid receipt with **Journal Number (12 digit)** in the first instance.
The candidates may visit the website **www.aponline.gov.in** to locate the AP online center nearest to them for fee payment.
- d. **SUBMISSION OF APPLICATION:** After payment of Fee, the candidates has to logon to the website **<http://apsrtc.cgg.gov.in>** to view the detailed Notification, User guide and Application form. The applicants have to invariably fill all the relevant fields in the Application. Immediately on submission of application the Applicant will get an acknowledgement in the form of a downloadable PDF document.
- e. Candidates have to submit application only through online mode well in advance of the last date to avoid last day rush.
- f. Hand written/typed/Photostat copies/printed application form will not be entertained by APSRTC by post or in person.
- g. Employees disengaged/kept away from duty (put-off duty) for involvement in misconduct / under suspension are not eligible to apply as departmental candidates.
